Added to this they will draw on the financial advisory work undertaken by the Avec team by providing practical tips for Governors in terms of asking key questions and advice on the monitoring of KPIs; use of benchmarking data; and key timescales for delivering savings, to help challenge and support the strategic planning of resources by schools and academy trusts.

MENTAL HEALTH AND WELLBEING GOVERNOR LEAD ROLE

Robust governance is crucial if mental health strategies are to be effective and the potential of the future Designated Senior LEAD for Mental Health is to be realised. This workshop provides an insight into how governing boards can ensure that they are holding Senior Leadership Teams to account in Developing a Whole School Approach to Mental Health and Wellbeing for pupils, staff and the wider community in which they serve. Governors will get the chance to have a go at a mini diagnostic which they will be able to work through and apply to the realities of their school. Governors will also have the opportunity to apply at a reduced cost to work towards the status of the Carnegie Mental Health and Wellbeing Lead Governor status.
