We want our community to be an **inclusive forum** for **constructive** discussion, to enable **collaboration**, **support** and **sharing** of best practice. Please remember our settings, skills and experience are all different. We all have different approaches that might work for us, but we strive for this to be a group that promotes and defines best practice.

This community is for school based staff from across the North East. Please check the rules of different groups for membership details. Workplace is a **members-only environment**, you must be invited to join and given an access code by the Schools North East Administrators. **Schools North East** reserve the right to check the details given at sign up are correct and reserve the right to reject your application if you are not from a North East School. What the community should be used for:

- Connecting with peers;
- Contributing to discussion;
- Adding ideas and thoughts on ways of working;
- **Supporting** and being supported in your role;
- Sharing case studies, best practice and information;
- Collaborative working;
- Engage in and debate research
- Unite schools through networks

We do not ask that you agree with everyone, and everything, but we do ask that you are respectful and contribute to conversations in an appropriate manner. We want everyone to feel welcome and give them the confidence to post.

Please:

- Show respect and courtesy to other users and their content at all times;
- Don't use offensive, abusive or threatening language, or promote discrimination;
- Challenge ideas, and not individuals. Please be open and kind if you are having disagreements with other members;
- Remember, we don't tolerate racism, sexism, homophobia, ageism or other forms of hate speech, or content that could be interpreted as such;
- Try to stay on topic and relevant;



- Don't spam or engage in self promotion or selling. We have a group for Jobs in Schools | North East, the region's jobs portal created by schools, for schools and all current vacancies on the portal will be advertised in this group. These are the only vacancies that are permitted to be advertised on groups on the platform. Schools North East Marketplace is for commercial organisations. We are happy for you to post recommendations based on experience;
- Make sure you have permission or a license to share or adapt the work of others and make sure you give credit where it's due;
- Try to avoid duplication of content from another website, although links are welcomed;
- Please acknowledge the sponsor of your group. Without their support we would not be able to keep this platform free to users. You group sponsor will, up to three times a year, post updates or special offers from their organisation.
- Don't do anything illegal.

It can be hard to communicate tone of voice in written form. Take care with humour and irony, which can often be ambiguous and may come across as sarcasm. If you don't understand what another community member means, try to assume the best intentions and if unsure then ask for clarification - remembering the rules on engagement.

The content posted in this group is **not public** and **should not** be shared outside of the group **without the express consent of the author(s)**.

The Administrators aim to monitor the community interaction, but we ask that members report inappropriate posts / behaviour; if you are found to consistently ignore the terms and conditions of the community then you may have your access revoked.

We may amend these terms from time to time.

Prohibited uses

You may not use our site:-

- In any way that breaches any applicable local, national or international law or regulation;
- In any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect;
- For the purpose of harming or attempting to harm young and/or vulnerable persons in any way;
- In any way which infringes any copyright, database rights, trademarks or other intellectual property;

 - Incites or contributes in any way to any unlawful, criminal or terrorist act or assists any party to commit the same;
 - Is likely to deceive any person;
 - Invades another's privacy, or causes annoyance, inconvenience or needless anxiety;
 - Is inaccurate (where it states facts) or is not genuinely held (where it states opinions);
 - Breaches any legal duty owed to a third party, such as an enforceable promise or undertaking to do or not do something;
 - Impersonates any person or organisation, or misrepresents your identity or affiliation
 with any person (including uploading any image portraying a child who you do
 not have parental responsibility for unless you have the express authority of
 that child (if over 12 years of age and able to make decisions relating to
 protection of personal data) or of the person with parental responsibility for the
 individual represented in the image; or
 - Gives the impression that the contribution emanates from Schools North East, when this is not the case.

You also agree:

- Not to access without authority, interfere with, damage or disrupt:

Commitment

We are committed to respecting your privacy whilst providing the highest possible quality service and we recognise your need to know that your personal data is being lawfully processed and held in compliance with the General Data Protection Regulation (EU) 2016/679 and also the UK Data Protection Act 2018. We refer to the legislation collectively in this Privacy Policy as the "Data Protection Legislation". Personal data is any information that relates to a living individual who can be identified from that data and so covers the information you may provide to us. Please refer to the Workplace Privacy Policy for further information on how they may store data.

Purpose

We provide you with the information set out in this Privacy Policy so that if you share your personal data with us you are aware of amongst other matters, what we do with it, how we protect the data you provide, how long we hold the data and to summarise your rights that you may exercise in relation to your personal data.

Data Controller

Schools North East is the data controller of your personal data and we will only collect information in accordance with the Data Protection Legislation. Our contact details are listed below. Schools North East owns the data on ConnectEd.

Data we Collect, Process and Control

We will collect email addresses on your sign up form and this will be stored on our CRM system, external to the ConnectEd Community. When signing up you will also be given the option to allow us to use your data for contacting you with information we feel may be useful to you in your job role. You will have the option to opt out of this. Users are responsible for creating their own profile on the site.



Use of Personal Data

Schools North East will store your information for the purpose of contacting you regarding your use on the platform if required, and will not be shared with a third party.

Our processing of your data is undertaken in accordance with the consent you give at time of engagement with the site.

What we do with the information we gather

Email addresses and place of work will be stored for the purpose of contacting you regarding your use on the platform if required and will not be shared with a third party.

Automated Decision Making (profiling using your personal data)

We do not undertake any automated decision making.

How long do we hold your personal data for

The posts you make will remain in the groups for as long as the platform exists. Your profile will be deactivated but still stored in case of accounts that are not active. If you ask for your account to be deleted then the profile will be permanently deleted.

Your rights as a data subject where we hold your personal data

Under certain circumstances, you have rights under data protection laws in relation to your personal data. These include the following rights.

- The right to request erasure of your personal data;
- The right to object to processing of your personal data;
- The right to request restriction of processing your personal data;
- The right to request the transfer of your personal data;
- The right to withdraw any consent you have given; The right to request correction of your personal data.

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

How we protect the security of your Personal Data

We are committed to ensuring the security of your personal data. In order to prevent unauthorised access to or disclosure of your personal data we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we hold concerning you. Access to the top level of the site is limited Admins who are Schools North East staff and all accounts are protected under password.

Tracking

Schools North East Workplace TERMS OF SERVICE

School's North East's Workplace by Facebook service (the "Service") provides you with the ability to internally communicate with other Schools North East ConnectEd members in a similar way in which you communicate with your friends through social media.
